

Terms and conditions

for the promotion "TIME FOR A CHANGE - UPGRADE TO ELECTRIC NOW"

These conditions of participation govern the participation in the "TIME FOR A CHANGE - UPGRADE TO ELECTRIC NOW " promotion (hereinafter referred to as the "promotion") run by Torqeedo GmbH, Claude-Dornier-Straße 1, 82234 Weßling (hereinafter referred to as the "organiser") as well as the collection and use of the data collected or communicated by the participants.

- 1. By participating in the promotion, the participant accepts these conditions of participation. Participants in this sense are end customers and thus consumers pursuant to § 13 BGB.
- 2. Only end customers who have reached the age of 18 at the time of participation are eligible to participate. This promotion is not valid for resellers. They are excluded from participation in the PROMOTION.
- 3. The promotion starts on 17.07.2023 and ends on 31.08.2023 (hereinafter referred to as the "promotion period"). During the promotion period, end customers have the opportunity to secure €300 by purchasing the new Torqeedo products listed below (hereinafter referred to as "promotion products") and participating in the organiser's promotion.

Promotion products:

- 1. Torqeedo Travel 1103 or
- 2. Torqeedo Travel 603

This promotion only applies to new promotional products purchased from the organiser's B2C online shop and from authorised dealers of the organiser, including their online shops. This promotion expressly does not apply to second-hand goods.

The amount of \in 300 will be transferred directly to the end customer by the organiser under the conditions stated under point 4.

- 4. The organiser is only obliged to pay out the amount of € 300 if a successful and sustainable conclusion of the contract is ensured and the following conditions are fulfilled:
 - The end customer must post a photo of themselves and the travel on their boat on Instagram or Facebook and tag the organiser. Instagram: @torqeedo_group / Facebook: Torqeedo;
 - within thirty (30) days of the invoice date, the end customer must take a photo or screenshot of this post and upload it together with the invoice or proof of purchase including the serial number at www.torgeedo.com/timeforachange and fill in the



following form fields: Gender, first name, last name, date of birth, address, country, email address, telephone number, dealer, bank details and/or PayPal address;

- the end customer agrees to these terms (<u>https://media.torqeedo.com/terms/cashback_promo_en.pdf</u>) and conditions of participation and the data protection provisions; and
- the end customer grants the organiser an irrevocable right to use their screenshots, images and Instagram and Facebook posts in this respect.
 After the organiser has checked the individual contracts, the amount of € 300 will be paid out to the end customer within approx. two (2) months. No payments will be made by the organiser in respect of contracts which are not notified or which are notified after the expiry of the 30-day period referred to in this clause 4.

No pay-outs will be made by the organiser for contracts cancelled by authorised dealers of the organiser and contracts cancelled or rejected by the organiser, revoked by the end customer or cancelled by mutual agreement.

- 5. The promotion is only valid for promotional products in stock or immediately available at the organiser and the authorized dealers of the organiser and is limited to a total of 500 (five hundred) promotional products. If the desired promotional product is not in stock, this shall not give rise to any claim to a promotional benefit at a later date. The Organiser expressly reserves the right to shorten the promotion period standardized under clause 3 if the budget of 500 (five hundred) promotional products are sold out.
- 6. Participation in this promotion cannot be combined with other promotions of the organiser that are independent of this promotion.
- 7. Participation in the promotion is only possible in the end customer's own name (purchaser of the promotional product). Subsequent offsetting or retroactive payment of the amount of € 300.00 is not possible. A cash payment or payment in kind is excluded. The entitlement to payment of the amount of € 300 is non-transferable.

8. The organiser reserves the right to terminate the promotion prematurely in cases of unforeseeable impediments to performance and disruptions that are beyond the organiser's control and could not have been prevented even if due care had been exercised by a prudent businessman and are not merely of a temporary nature (force majeure).

9. The law of the Federal Republic of Germany shall apply. The exclusive place of jurisdiction is 82234 Weßling.

You have a right to information about your stored data at any time. Only employees of Torqeedo GmbH from the sales and accounting departments who need the data to perform their tasks have access to the data.
